I. BUDGET REVIEW

- ***Library Budget Review-*** discussed overall budget and the increases. Discussed library addition. Received notice from National Endowment for the Humanities Challenge Grant that our application was not approved. Library will not be asking for a Bond vote at the 2008 Town Meeting.
- ***Recreation Budget Review-*** discussed overall budget and the increases.
- ***Town Clerk's Office Budget Review-***discussed overall budget. Also discussed whether to draw from the Records Reclamation Fund to pay for a portion of this year's work; which is proposed to be \$10,000. The fund receives about \$6500 per year in filing fees, this money could be used to pay for a portion of this year's work keeping the fund level.
- ***General Government-*** discussed overall budget.
- ***Other Departments***
 - ***Senior Center Clock Tower Request-*** the center has requested the Town to pay for a portion of the clock tower repairs. Board asked TA to contact center for additional information.
 - ***PV Cemetery Association-*** Board was not represented
 - ***Morristown Cemetery Association-***Board was not represented.
- ***Revenues-*** MRS revenues are due to increase with the new budget due to new fee schedule.
- ***Capitol Budget Plan-*** reviewed. Board agreed that they will not ask for loader replacement at Town Meeting.
