SPECIAL MEETING

JUNE 27, 2006

PRESENT: JOIE MARSHALL, GLORIA WING, STEVE LEACH, RON STANCLIFF, TODD YANDOW, DENNIS MCALISTER., MARK FAITH.

Meeting brought to order at 5:30PM.

MINUTES: 5/2/06 Approved on motion by Gloria, seconded by Ron, passed.

AMENDMENT TO BYLAWS: Discussion re: changing the annual meeting to the fall. We would have year end budget figures by then. Gloria moved to have the annual meeting the first Tuesday in October, seconded by Dennis, passed.

UPDATES:

Water lines: New lines in new part of cemetery are causing problems w/ lines in old part because of increased volume. After discussion, Todd will check on ball valve to protect old lines. Gloria will check w/ Young re: installation of new lines in the fall. Also will check to see how much money we have left in the Copley Fund.

Joie asked Todd about the replacement of the fountain. He has found a place that may be able to help and will look into pricing.

Fund raising: No action at this time. Cathy Lanman has offered to pay for the replacement of the trees.

Trees: Gloria reported on the review by Ray Toolan re: the status of the trees. Five should come down ASAP and are marked w/ blue ribbon. Gloria has contacted W&L and they have agreed to cut down the marked trees. (SOON) The others need some pruning of dead limbs, etc. to enhance the longevity of the trees. Gloria will contact Corey Hathaway re: this and stump removal. She stated that Ray advised repalcing the trees w/ sugar or red maples and not the silver. Gloria will check w/ B&B. Ron to check two dead trees on the east bank on Wash. Hgwy. Ron had been cutting the dead trees by the bank going down to Randolph Rd and one that came down in the storm.

Pond: Joie reported that she & Gloria met w/ Chuck Mitchell re: the status of the pond. Expense of the solution not possible. Joie has spoken w/ Mike Day re: cleaning out the sand and cat tails. Road crew has two drains there that are essential.

Vault: Todd has checked as had Mark. No damage in vault, maybe caulking would be temporary fix on the outside corner of the wall. Mark is having a problem w/ the door, closes hard, also not secure. Joie will ask Lee to price a steel door.

NEW BUSINESS:

Vt. Monument: Joie discussed the problem w/ the company and the letter that she sent. Mark explained that Chris Martin is learning on the job and will work w/ him.

Mark discussed the unmarked graves and suggested that a small marker be placed on the grave, Cost \$10, to the family.

Gloria reported that the files done to update the cemetery are not being kept up by the Town Clerk's Office. She has discussed it w/ Francis and will follow up.

Todd reminded that we had raised Mike Goodell's salary by 3% (\$10.85) as of July 1st. Gloria will send memo to Town (Carol).

Gloria asked Dennis to describe his new venture re: the National Cemetery archives and location of family by contacting him or the agency.

Meeting adjourned on motion by Gloria, seconded by Dennis, at 6:22PM.
