The Board of Civil Authority of the Town of Morristown, duly notified and warned, met at the V.F.W. Hall, Pleasant Street in said town on Tuesday, the 18th day of May 2004, at 7:00 P.M.

Meeting opened at 7:00 by Clerk Wilson.

Pursuant to Title 24 V.S.A § 1535, motion was made by Thomas Hirschak, with a second by James Paige to consider abatement of real estate and personal property taxes assessed as presented by the Town Clerk. After the 2003 Grand List was lodged, the Board of Listers made adjustments to the values of hangars located at the Stowe-Morristown State Airport. The B.C.A. voted unanimously to correct the taxes receivable for 2003, and abate taxes in the amount of \$2,412.56. (See attached list.)

Pursuant to Title 24 V.S.A § 1535, motion was made by Ed Wilson, with a second by Theresa Breault to consider abatement of small amounts due where new interest added and receipt of payments crossed in the mail. Total approved for abatement: \$91.84. (See attached lists.)
